MEETING TOPIC 1 - Andy Meeuwsen - Country Financial

During the Project Wildfire meeting, several issues regarding insurance and wildfire risk were discussed. The main concern raised by participants was the increasing premiums and non-renewals of home insurance policies, despite homeowners having no claims or previous issues.

The use of wildfire scores based on proprietary algorithms and overlay maps was highlighted as a major factor in determining insurance eligibility and premiums. Insurance carriers are now placing a significant emphasis on defensible space and tree clearance around properties, with specific guidelines for distances and tree heights.

The subjective decision-making of underwriters was also mentioned, as they have the authority to accept or reject risks based on their own judgment. The challenges faced by homeowners in obtaining insurance for second homes and vacation rentals were also addressed, with insurance carriers being more cautious due to the higher risk of properties being unoccupied during a wildfire. The lack of transparency in the insurance industry's risk assessment models and the need for collaboration between insurance companies, fire departments, and forestry

experts to improve understanding of wildfire risk were highlighted as important areas for future action.

The meeting concluded with a discussion on potential legislative measures to address the insurance industry's response to wildfire risk, including the possibility of a certification program for properties that have implemented wildfire mitigation measures. Overall, the meeting shed light on the complexities and frustrations faced by homeowners and insurance agents in navigating the insurance landscape in wildfire-prone areas.
